

## ANATOMIC PATHOLOGY AND CTYOLOGY SERVICES

Requests for Anatomic Pathology and Cytology services require a Surgical Pathology/Cytology Requisition Form. For details, see Laboratory Services Manual Introduction -- Surgical Pathology -- Submission of Specimens to the Laboratory. A report is rendered upon completion of each case. Contact the Department of Pathology and Laboratory Services with any questions.

\* The extent of tissue examination can be determined only during the pathologist's examination of the specimen. The examination may require special studies, markers, or stains as deemed appropriate for proper evaluation. These additional tests will result in additional charges and may affect TAT.

\* The fee for histopathology services will vary depending upon the number of specimens submitted, the size and complexity of the specimen and the necessity for additional tests. The fees and submission of bills to patients, customers, and health plans will be based on Current Procedural Terminology (CPT) codes.
